GENERAL TERMS AND CONDITIONS

SERVICES

These General Terms and Conditions are applicable to companies, self-employed persons and freelancers. Green Point France provides services appropriate to the nature and scope of the description of an event in the current event program or in accordance with a separate written agreement. In exceptional cases, Green Point France reserves the right to change lecturers and/or make changes in the program sequence. Seminars are dedicated to service engineers and will mostly be "hands-on" driven and are intended exclusively for technicians being qualified for refrigerant handling, maintenance companies, installers, design offices.

REGISTRATION AND CONFIRMATION

Registrations must be addressed in writing to Green Point France by e-mail. By registering, the participants undertake to participate in the event or seminar and pay the corresponding fees and costs. Registrations will be handled on a first-come-first- serve basis and confirmed by e-mail.

Registrations and reservations by phone will not become effective until registration in writing (including electronic registration) is received. By registering in writing, the participants accept the General Terms and Conditions as integral part of the contract. Secondary verbal agreements always require confirmation in writing. The training agreement becomes effective upon written confirmation. Individual parts of events cannot be booked unless specifically stated in the event program.

CANCELLATION AND PROGRAM CHANGES BY GREEN POINT FRANCE

Green Point France reserves the right to cancel an event if the number of participants is too low, a lecturer cancels, a hotel closes, in the event of a force majeure or due to any circumstances that are not the fault of Green Point France. Program changes shall also be expressly reserved, as long as they do not affect the overall character of the event. A change in lecturers, immaterial changes in the sequence of an event or an acceptable change in the venue of an event does not entitle the participant to a reduction in price or to withdraw from the agreement. In the event of cancellation by Green Point France, it shall in any case only be required to refund the payments already made. Any further claims shall be excluded, except in cases of intentional or grossly negligent behavior on the part of employees or other agents of Green Point France. Green Point France shall not be liable for the contents of the seminar presentations or of the accompanying work documents or for the way in which they are conducted, unless due to intentional or gross negligence on the part of Green Point France or one of its agents.

CANCELLATION OR REBOOKING BY THE PARTICIPANT

Cancellations must be accompanied by a written explanation. The date of receipt at Green Point France shall apply. Unless a replacement participant can be presented, a processing and cancellation fee shall be charged. Until 10 days prior to the event, it shall amount to 50% of the registration fee plus the current legal VAT. If cancelled within 14 days prior to the event, if the participant fails to appear without prior cancellation or cancels after the beginning of the event, the full registration fee as invoiced shall be payable. Participants are not entitled to set-off, reduction or assertion of a withholding right, unless their claims have been stated as legally binding and are uncontested

EVENT DOCUMENTS

PLACE OF JURISDICTION AND APPLICABLE LAW

The legal relationship of the contractual parties arising from or in connection with the agreement is governed by the law of the France to the exclusion of the UN Sales Convention (CISG). The place of jurisdiction for any legal dispute arising from or in connection with the agreement is the registered office Green Point France. In the event that individual clauses of the above General Terms and Conditions are invalid, this shall not affect the validity of the remaining provisions.

COVID-19

In case of impossibility to hold the seminars in consequence of a COVID-19 related legal or administrative measure, you will be able to select another date during one year from the date initially planned.
